Aim of the Workshop

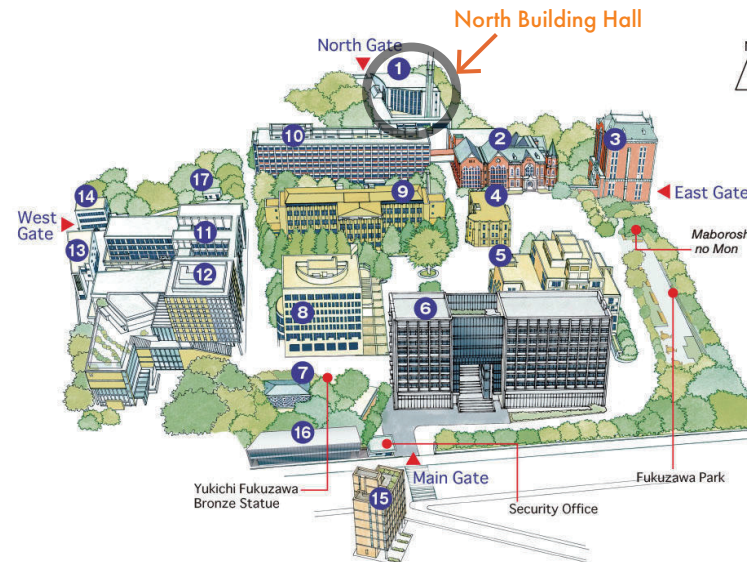
